## FAIR - MARKETS

#### 2. PARTICIPANTS

j. For WTI (SPOT & Futures) and BRENT (Spot & Futures), one "effective lot" shall mean 10 lots traded round turn on the FairMarkets trading platform.

k. Closed positions more than two minutes will be taken into consideration while calculating required minimum trading volume.

- m. Open trades will not be included into the calculation of required minimum trading volume. 未平倉訂單將不被計入有效交易量。
- n. Net deposit and required minimum trading volume calculation will include all accounts under a client. This also means a client cannot apply twice just because he/she has an additional account under the same name.
