# 親友推薦計劃條款與細則



Refer a Friend program is available to all new and existing direct clients who want to share their FairMarkets trading experience with their friends. A reward amount up to €/\$/£ 250 will be added to both referrer and referred account when the referred friend fulfils the minimum trading requirements. The program is only available for client who opens a Standard Variable account and the referred have to open a Standard Variable account. This program is available from 11 September 2022 until 31 March 2023.

#### 1. ORGANIZATION 組織機構

#### 2. PARTICIPANTS 參與資格

- a. All new and existing direct clients can benefit from this offer by referring a friend. 所有的新客戶和直客均可參加"親友推薦計劃"。
- b. The referred friend must open a live account with FairMarkets and only Standard Variable and Standard Fixed ac-count will be considered.

被推薦人須在FairMarkets開設真實帳戶,只有開設標準-浮動帳戶視為有效。

- c. Referred friend cannot be an IB client or under Money Managers. 被推薦人不能為代理名下或資金經理名下的客戶。
- d. Referrer must send a request from MyFairMarkets to participate in Refer a Friend Program. 推薦人必須通過 MyFairMarkets 申請參加本次活動。
- e. Refer a Friend request needs to be approved by FairMarkets. 該申請需要通過FairMarkets的批准。







#### 3. ELIGIBILITY 申請資格

- a. All applicants must be 18 years old or over, subject to our general Terms of Business and Terms and Conditions. 所有申請人必須年滿18歲或以上,須遵守我們的一般商業條款和細則。
- b. All clients who meet the requirements of our Terms and Conditions are eligible to apply for the program. 所有符合我們條款和細則要求的客戶都有資格申請本活動。
- c. If an eligible client has been disqualified from the offer for any reason, he/she cannot apply for the program again. 如果符合條件的客戶因任何原因被取消資格,他/她不能再次申請該活動。

#### 4. RESTRICTION 限制條件

- a. No staff members, and/or their relatives, of Fairmarkets International or any associated company, may take part in this program.
  - FairMarkets International 或任何關聯公司的員工和/或其親屬不得參加本次活動。
- b. If the referred friend is immediate family member of the referrer, already has an account with FairMarkets or has been referred by someone else then the account of referred friend will be invalid. 如果被推薦人是推薦人的直系親屬,已經在FairMarkets有帳戶或被其他人推薦過,那麼被推薦人的帳戶將視為無效。
- c. Referred friend cannot benefit from any other bonus promotions. 被推薦人不能參加其他優惠活動。

#### 5. MECHANISM OF THE PROMOTION 活動機制

a. The referrer and referral reward varies according to the referred friend's trading volume. 推薦人和被推薦人的獎勵將根據被推薦人的交易量而定。

b. FairMarkets will pay the referrer and referred friend €/\$/£ 20 if the referred friend has traded at least 5 effective lots within **two months** of their account being opened, €/\$/£ 100 if at least 20 effective lots have been traded, and €/\$/£ 200 if at least 50 effective lots have been traded.

如果被推薦人在開戶後的兩個月內交易了至少5個有效手,FairMarkets將向推薦人和被推薦人支付€/\$/£20;如果交易了至少20個有效手,FairMarkets將支付€/\$/£100;如果交易了至少50個有效手,fairmarkets將支付€/\$/£250。







c. When calculating trading volume, only currency pairs, XAUUSD, XAGUSD, GOLD (Spot), SILVER (Spot), WTI (SPOT & Futures) and BRENT (Spot & Futures) trades will be considered.

在計算交易量時,只有貨幣對,XAUUSD, XAGUSD, GOLD(現貨),SILVER(現貨),WTI(現貨及期貨)和BRENT(現貨 及期貨)的交易視為有效。

- d. One "effective lot" shall mean 1 (one) lot traded round turn on FairMarkets trading platform. 一個"有效手"是指在FairMarkets交易平臺交易一(1)完整手數(即已平倉)。
- e. For GOLD (Spot), WTI (SPOT & Futures) and BRENT (Spot & Futures), one "effective lot" shall mean 10 lots traded round turn on FairMarkets trading platform.

對於黃金(現貨), WTI(現貨及期貨)和BRENT(現貨及期貨), 一個"有效手"是指在FairMarkets交易平臺交易十 (10)完整手數(即已平倉)。

- f. For SILVER (Spot), one "effective lot" shall mean 50 lots traded round turn on FairMarkets trading platform. 對於白銀(現貨),一個"有效手"是指在FairMarkets交易平臺交易五十(50)完整手數(即已平倉)。
- g. The term round-turn means a closed position. This doesn't include a fully hedged position where a client may be long and short of the same market.

"來回交易"一詞是指已平倉。這不包括完全對沖的訂單,客戶可能在一個市場同時做多和做空。

- h. Only closed positions more than two minutes will be taken into consideration while calculating trading volume. 在計算交易量時,只有超過兩分鐘的訂單視為有效。
- i. Illegal trading positions will not be taken into consideration while calculating trading volume. 在計算交易量時, 非法交易訂單將不被計算在內。
- j. Open trades will not be included into the calculation of trading volume. 未平倉訂單將不會被計入有效交易量。
- k. bonus will be paid to the referrer and referred friend's account within 5 (five) business days after referred friend meets the trading volume requirement.

I. The client can apply for this bonus offer by filling the Refer a Friend form in MyFairMarkets or sending an e-mail to client's representative.
